RIDER EV-RES
Plug-In Electric Vehicle Charging Rate Rider

APPLICABILITY

This Rider is available on a voluntary basis to residential consumers who are receiving service under the Residential Time of Day (Energy Only or Demand/Energy) schedule and have a Cooperative approved Level 2 Electric Vehicle Charger with time-clock charging capability. Residential shall be defined as a residence, condominium, mobile home, or individually-metered apartment that provides independent and permanent facilities complete for living, sleeping, eating, cooking, and sanitation. Prior to receiving service under this Rider, the consumer must have a signed “Electric Vehicle Charging Agreement” between the consumer and the Cooperative. The obligations of the Cooperative in regard to service under this schedule are dependent upon the member having and agreeing to program the Level 2 Electric Vehicle Charge to only charge during the Rider’s available charging hours as defined herein.

For purposes of this Rider, the applicant must:

1. Provide electric vehicle registration card corresponding to associated electric address with the Cooperative.
2. Provide proof the vehicle can be recharged from an external plug-in source of electricity.
3. Notify the Cooperative should ownership or lease of the vehicle change.

MONTHLY RATE RIDER

The standard Electric Service Rate Schedule shall be applicable for all periods during the month other than the Electric Vehicle Charging period. During the Electric Vehicle Charging Period the following rate shall apply:

First 400 kWh per month	4.50¢ per kWh
All Excess kWh	At the Standard Rate

DETERMINATION OF CHARGING PERIOD

The Electric Vehicle Charging period shall be the hours between 10:00 p.m. and 5:00 a.m. for all days of the week.

EXCLUSIONS

Transportation equipment such as electric motorcycles, golf carts, all-terrain and off-road vehicles do not qualify under this Rate Rider.

RATE SCHEDULE RT-E
Residential Time-of-Day Service – Energy Only

APPLICABILITY

This schedule is available on a voluntary basis applicable to year-round single-phase residential consumers who would otherwise be served under the Single-Phase General Service or Residential All-Electric Service schedules. Residential shall be defined as a single-family residence, condominium, mobile home, or individually-metered apartment that provides independent and permanent facilities complete for living, sleeping, eating, cooking, and sanitation. Non-residential services are excluded from this rate. Service under this schedule is subject to the Cooperative's established rules and regulations.

TYPE OF SERVICE

Service under this schedule shall be single-phase, 60 hertz, at available secondary voltages.

MONTHLY RATE

Basic Facilities Charge: \$ 32.00 per Month

Energy Charges:

All On-Peak Energy	36.57¢ per kWh
All Off-Peak Energy	7.32¢ per kWh

MINIMUM MONTHLY CHARGE

The monthly minimum bill shall be the Basic Facilities Charge.

MINIMUM ANNUAL CHARGE

Service under this schedule is intended for consumers requiring service on a year-round basis. In no event shall the minimum annual charge be less than twelve times the applicable Basic Facilities Charge.

Consumers requesting Service to be reconnected, which has been disconnected for less than twelve months, shall be responsible for the greater of:

1. The monthly minimum, as determined above, times the number of months the service was disconnected; or
2. The Cooperative's current reconnection charge.

WHOLESALE POWER COST ADJUSTMENT CHARGE

The above kWh charges may be increased or decreased by 0.001 cents per kWh, or major fraction thereof, adjusted for line losses and North Carolina gross receipts taxes, by which the Cooperative's cost of purchased power, on a per kWh basis, exceeds or is less than the Cooperative's base cost of power, as prescribed in the Wholesale Power Cost Adjustment Rider.

DETERMINATION OF ON-PEAK AND OFF-PEAK PERIODS

On-Peak and Off-Peak Hours shall be defined as the following:

- A. For the period April 16 through October 15, the On-Peak Hours shall be the hours between 2:00 p.m. and 6:00 p.m., for all days of the week.
- B. For the period October 16 through April 15, the On-Peak Hours shall be the hours between 6:00 a.m. to 9:00 a.m., for all days of the week.
- C. The Off-Peak Hours shall be all other times.

PRE-PAY BILLING OPTION

Basic Facilities Charge: \$ 1.06 per day

This schedule is applicable for qualified consumers electing Pre-Pay billing under the Cooperative's Pre-Pay Service Program. The Pre-Pay billing option under this schedule is subject to the Cooperative's established rules and regulations.

REPS AND EE ADJUSTMENTS

The consumer's monthly bill shall also include the Renewable Energy Portfolio Standard (REPS) and Energy Efficiency (EE) adjustments based upon the revenue classification of the account. The revenue classifications and monthly charges are shown in the Cooperative's Renewable Energy Portfolio Standard and Energy Efficiency Riders.

TAXES

North Carolina Sales Tax will be added to the rate and shown on the bill.

TERMS OF PAYMENT

The above rates are net. Bills are due and payable within 25 days of the billing date shown on the bill. In the event the current monthly bill is not paid, it shall be considered delinquent, may be subject to a late fee, and service will be suspended in accordance with the Cooperative's established Service Rules and Regulations.
